

Probation and Parole in the United States, 2021

An estimated 3,745,000 adults were under community supervision at yearend 2021, a 3.5% decline from the 3,881,600 who were supervised in the community on January 1, 2021 (figure 1).¹ This decline is attributed to both a reduction in the number of persons on probation, who made up 79% of the community supervision population, and the number on parole. During 2021, the number of persons on probation decreased from 3,032,400 to 2,963,000 (down 2.3%). The number of persons on parole fell from 864,200 to 803,200 (down 7.1%) during 2021, the largest annual change in the population in almost 30 years (not shown).

Findings are from the Bureau of Justice Statistics' (BJS) Annual Probation Survey, Annual Parole Survey, and Federal Justice Statistics Program,

HIGHLIGHTS

- At yearend 2021, an estimated 3,745,000 adults were under community supervision (probation or parole), down 136,600 from January 1, 2021.
- An estimated 1 in 69 adult U.S. residents were under community supervision at the end of 2021, the lowest rate since 1987.
- During 2021, the probation population decreased in 31 states and the U.S. federal system and increased in 18 states and the District of Columbia.
- The rate of adults on probation at yearend 2021 (1,143 per 100,000 adult U.S. residents) was at its lowest point in 36 years.

- At yearend 2021, 803,200 adults were on parole supervision, a decrease of 7.1% from January 1, 2021 and the largest annual change since 1992.
- The parole population in 2021 was at its lowest point since 2006, when 798,200 persons were supervised on parole.
- During 2021, the parole population fell in 44 states, the District of Columbia, and the U.S. federal system's term of supervised release, while 6 states had an increase in the parole population.
- Among adults on probation whose most serious offense was known, the percentage on supervision for a violent offense rose from 18% in 2011 to 26% in 2021.





which collect data on adults placed on correctional supervision (entries) or removed from supervision (exits) during the reporting year and on characteristics of the population at yearend. These are the only national data collections that cover community corrections in all 50 states, the District of Columbia, and the U.S. federal system.

For this report, an adult is defined as any person subject to the jurisdiction of an adult court or correctional agency. Reporting methods for some probation and parole agencies have changed over time, resulting in changes to previously reported statistics including 2020 and earlier. (See *Methodology*.) Appendix tables 5 through 13 present additional 2021 data on probation and parole.

During 2021, both probation and parole populations declined

From yearend 2011 to yearend 2021, the total adult community supervision population fell 22%, from 4,818,300 to 3,745,000 **(table 1)**. Most of this decrease was due to a decline of 25% (1 million) in the number of adults on probation. The community supervision population has declined each year since 2007 and, at yearend 2021, was at its lowest level since 1994.²

The probation population declined for the fourteenth consecutive year in 2021, falling below 3 million for the first time since 1994. Between 2011 and 2019, the U.S. parole population remained relatively stable, then decreased 8.6% from yearend 2019 to yearend 2021.

The probation population had an annual decrease of 2.3% in 2021, about a quarter of the 8.3% annual decline observed during the COVID-19 pandemic in 2020 (figure 2). In 2021, the parole population had its largest recorded annual decrease (down 7.1%) since 1980, when BJS started collecting probation and parole information on a yearly basis (figure 3).

31 states and the U.S. federal system had a decrease in their probation population in 2021

Probation populations decreased in 31 states and the U.S. federal system during 2021, with a total decline of 108,500 adults under probation supervision (table 2). California, Pennsylvania, New York, Washington, and Colorado made up the largest portion of the decline, with a collective decrease of 67,300 adults on probation.

While the probation population in most states declined in 2021, more than a third saw increases. Texas had the largest absolute increase in persons on probation during 2021 (up 10,400), with 18 other states and the District of Columbia also experiencing growth in their probation population. (See appendix table 6.) Jurisdictions with increases during 2021 accounted for 48% of all persons on probation in the United States at yearend 2021.

During 2021, the parole population fell in all but six jurisdictions

From January 1 to December 31, 2021, the parole population decreased in 44 states, the District of Columbia, and the U.S. federal system's term of supervised release (table 3).³ These jurisdictions supervised 95% of the total parole population in 2021. During that time, adults under parole supervision in the United States decreased by 61,000. California, Pennsylvania, Texas, New York, and Illinois led this decline. Parole populations grew in six states during 2021, with Mississippi accounting for almost 40% (500 adults) of the total increase. (See appendix table 10.)

The rate of adults supervised in the community fell to 1,445 per 100,000 adult U.S. residents in 2021

During 2021, 1 in 69 adults in the United States were being supervised in the community (table 4). From 2011 to 2021, the community supervision rate decreased from 2,017 to 1,445 per 100,000 adult U.S. residents. The probation rate was 1,143 per 100,000 adult U.S. residents in 2021, marking the fourteenth consecutive year of decline. The rate of persons on parole fell to 310 per 100,000 adult U.S. residents in 2021, after decreasing every year since 2015.

During 2021, entries to and exits from probation both rose after an almost 30% decrease in total movements from 2019 to 2020

Movements onto (entries) and off of (exits) probation increased 10% from 2020 to 2021 (from 2,703,400 to 2,972,500), after substantially decreasing 28% from 2019 to 2020 (from 3,780,800 to 2,703,400) (figure 4). Entries and exits reflect the administrative caseloads of probation agencies. A person can enter or exit the probation system several times during a year or concurrently serve multiple probation sentences for separate crimes. Probation entries increased 17%, from an estimated 1,216,100 at yearend 2020 to an estimated 1,419,300 at yearend 2021. Probation exits increased 4%, from an estimated 1,487,300 in 2020 to an estimated 1,553,200 in 2021. Exits in 2021 exceeded entries by 133,900, about half the gap reported in 2020 (271,200).

Probation exits include successful completions of supervision; exits to serve a period of incarceration, including to receive treatment; exits due to absconding, detainment, or other unsatisfactory reasons besides incarceration; and exits due to death or other reasons. Successful completion of probation accounted for 60% to 69% of such exits each year from 2011 to 2021 (table 5). A period of incarceration accounted for 14% to 19% of probation exits each year from 2011 to 2021 among adults whose type of exit was known. About 9% of adults on probation with a known exit type exited for an unsatisfactory reason other than incarceration in 2021 (such as absconding or being discharged to a warrant), and 13% exited due to death or other reasons. In 2021, the type of probation exit was unknown or unreported for almost 34% of adults on probation.

Parole entries declined while exits increased from 2020 to 2021

Total movements onto and off of parole decreased from 780,800 in 2020 to 767,200 (down 13,600) in 2021 (**figure 5**). During that period, the number of adults entering parole decreased from an estimated 392,400 to

357,000 (down 35,400), while the number exiting parole increased from 388,400 to 410,200 (up 21,800). In 2021, the gap between parole entries and exits (53,200) was the largest it had been in more than 20 years.

Among adults with known reasons for exiting parole in 2021, about 65% exited after successfully completing it, down from 69% in 2020 **(table 6)**. About 27% exited in 2021 to serve a period of incarceration (up from 23% in 2020), and about 3% exited in another unsatisfactory way (similar to the percentage in 2020). In 2021, almost a quarter (23%) of exits from parole were for an unknown or unreported reason.

The percentage of adults on probation or parole for a violent offense increased from 2011 to 2021

Among adults on probation whose most serious offense was known, the percentage supervised for a violent offense rose from 18% in 2011 to 26% in 2021. Most of this increase was among adults with a violent offense other than domestic violence or a sex offense. Smaller shares were on probation for DUI/DWI (11%) or a property offense (24%) in 2021 than in 2011 (15% DUI/ DWI and 27% property), while similar percentages were on probation for drug offenses (about 25% in each year). The most serious offense was unknown for almost 4 in 10 of all adults on probation in 2011 and 2021. From 2011 to 2021, the share of adults with a known offense type who were on probation for a felony increased from 53% to 64%. Of all adults on probation in 2021, almost a third had been sentenced for a misdemeanor and 13% had an unknown or unreported offense type.

In 2021, almost two-thirds of adults on probation with a known supervision status were on active probation. Active probation includes persons who are required to regularly contact a probation authority in person, by mail, by telephone, or electronically. Eighteen percent of the remaining adults on probation were considered absconders or had a warrant, while 11% had only financial conditions left to fulfill or were on inactive supervision. Just over a fifth (22%) of all adults on probation had an unknown status of supervision in 2021.

Females made up 24% of the probation population whose sex was reported in 2021, similar to the 25% in 2011 (table 7). Of the 70% of adults on probation in 2021 whose race or ethnicity was known, 54% were white and 30% were black.

Among adults on parole whose most serious offense was known, a larger percentage in 2021 (36%) than in 2011 (28%) had been incarcerated for a violent offense (table 8). Smaller shares were on parole for a drug (30%) or property (19%) offense in 2021 than in 2011 (33% drug and 23% property), while the share on parole for a weapons offense increased from 3% in 2011 to 6% in 2021. The most serious offense was unknown for 22% of all adults on parole at yearend.

Among adults on parole at yearend 2021 with a known supervision status, 82% were on active supervision.

Active parole includes a requirement to contact a parole authority in person, by mail, by telephone, or electronically.

Females made up a similar percentage of adults on parole whose sex was known in 2011 (11%) and 2021 (12%). Among adults on parole in 2021 with a known race or ethnicity, 44% were white, 37% were black, and 16% were Hispanic. In 2021, almost a fifth of all adults on parole did not have a reported race or ethnicity.

Methodology

The Bureau of Justice Statistics (BJS) began the Annual Probation Survey and Annual Parole Survey in 1980. The surveys collect data from U.S. probation and parole agencies that supervise adults. These data collections define adults as persons subject to the jurisdiction of an adult court or correctional agency. Juveniles sentenced as adults in a criminal court are considered adults. Juveniles under the jurisdiction of a juvenile court or correctional agency are excluded from these data.

Data collections

Starting in January of each calendar year, the two surveys collect data on the number of adults supervised in the community on both January 1 and December 31 of the previous calendar year, the number of entries to and exits from supervision during the reporting year, and the characteristics of the probation and parole populations at yearend. Both surveys cover the 50 states, the District of Columbia, and the U.S. federal system. BJS depends on the voluntary participation of state central reporters and separate state, county, and court agencies for these data. Data for the U.S. federal system are provided through BJS's Federal Justice Statistics Program, which obtains community supervision data from the Office of Probation and Pretrial Services, Administrative Office of the U.S. Courts.

2021 Annual Probation Survey

The 2021 Annual Probation Survey was sent to 500 agencies. The 500 agencies included 40 central state agencies and the District of Columbia; 458 separate state, county, or court agencies; and the federal system. States with multiple state agencies included Alabama (3), Colorado (8), Florida (41), Georgia (2), Idaho (45), Kentucky (3), Michigan (129), Missouri (2), Montana (4), New Mexico (2), Ohio (182), Oklahoma (3), Pennsylvania (3), Tennessee (3), and Washington (32). Pennsylvania and Georgia are both included as central state agencies, but each provides data from two departments within the state government.

Of the 500 agencies in the population frame, 120 did not provide data or provided incomplete data for the 2021 data collection. These included 2 in Colorado, 7 in Florida, 16 in Idaho, 1 in Kentucky, 33 in Michigan, 1 in Missouri, 1 in New Mexico, 1 in Nevada, 48 in Ohio, 1 in Vermont, and 9 in Washington. In addition, four agencies reported that they no longer supervise probationers, making them ineligible for the survey: three in Idaho and one in Pennsylvania. About three-quarters (76%) of the 496 eligible agencies responded to all four key items asking about the population at the beginning or end of the year and the number of probation entries and exits. The remaining 24% did not respond to at least one of the four key items, including the 74 agencies that provided no data and 46 agencies that provided incomplete data. Of the 46 agencies that provided incomplete data, 2 were in Florida, 7 in Idaho, 10 in Michigan, 1 in Nevada, 22 in Ohio, 1 in Vermont, and 3 in Washington.

2021 Annual Parole Survey

The 2021 Annual Parole Survey was sent to 57 agencies: 53 central state reporters; the federal system; the District of Columbia; and 2 separate state, county, or court agencies. In this report, federal parole includes a term of supervised release from prison, mandatory release, parole, military parole, or special parole. A federal judge orders a term of supervised release at the time of sentencing, which is served after release from a federal prison sentence. In the case of Alaska, persons on probation or parole are supervised under a common program, and the data provider is unable to report probation and parole counts separately. Combined counts of persons on probation or parole were reported to BJS through the probation questionnaire. January 1 and December 31 counts were imputed for Alaska, and these figures were deducted from the combined reported totals for the calculation of the state's January 1 and December 31 counts of persons on probation. Of these agencies, three were determined to be ineligible, including one in Alaska, one in Maine, and one in Pennsylvania.

Of the 54 eligible agencies surveyed for 2021, all agencies provided the population count for the beginning or end of the year or the number of parole exits or entries, and 96% responded to all of these key items. Vermont and one of the reporting agencies for California did not provide complete data on the four key survey items, and Alaska's data were estimated using the combined community supervision data provided.

Persons under community supervision in the federal system

Since the enactment of the Sentencing Reform Act of 1984 on November 1, 1987, offenders sentenced to federal prison are no longer eligible for parole but are required to serve a term of supervised release following release from prison. Those sentenced to prison prior to November 1, 1987 continue to be eligible for parole, as do persons violating laws of the District of Columbia, military offenders, and offenders transferred under foreign treaties. (See https://www.uscourts.gov/ services-forms/overview-probation-supervised-releaseconditions.)

In 2008, the Annual Parole Survey added a new type of entry-to-parole category (term of supervised release) to better classify the large majority of entries to parole reported by the federal system. This entry is a period of release to the community that follows a period of incarceration based on a determinate sentencing statute. Both periods are determined by a judge at the time of sentencing. For details about estimation methods used to analyze national trends for all types of entry to parole, see *Probation and Parole in the United States, 2010* (NCJ 236019, BJS, November 2011).

The Sentencing Reform Act also required the adoption and use of sentencing guidelines, which took effect on the same day as enactment. Many offenses for which probation had been the typical sentence prior to this date, particularly property and regulatory offenses, subsequently resulted in sentences to prison. Changes in how persons released from federal prisons are supervised in the community were first described in the BJS report *Federal Offenders under Community Supervision*, 1987–96 (NCJ 168636, BJS, August 1998) and were updated in *Federal Criminal Case Processing*, 2002: With *Trends* 1982–2002, *Reconciled Data* (NCJ 207447, BJS, January 2005).

Adjustment and changes in parole and population counts

Dual community supervision status

Some persons on probation or parole may have dual community supervision statuses because they were serving separate probation and parole sentences at the same time. Beginning with 2007 data, BJS began collecting information on the number of persons on parole who were also on probation at yearend. To avoid double counting, the total community supervision population reported in figure 1, table 1, and appendix table 5 has been adjusted based on available information by excluding the total number of persons on parole who were also on probation. As a result, the probation and parole counts do not sum to the community supervision population. All counts for persons on parole with dual community supervision statuses reflect data reported by parole agencies that could provide the information for the reporting year (table 9). In 2021, agencies in 24

jurisdictions provided such data. The total number of persons on parole who were also on probation may be underestimated due to nonresponding agencies.

Changes in reported probation and parole populations

In each collection year, respondents are asked to provide both the January 1 and December 31 population counts for the previous year. Therefore, while the December 31, 2020 count was collected in 2021, the January 1, 2021 count was not collected until 2022. At times, the January 1 count from a given year may differ from the December 31 count of the prior year, given the normal daily flow of entries and exits. Additionally, the difference reported may have resulted from administrative changes, such as—

- implementing new information systems, leading to data review and cleanup
- reconciling records of persons on probation
- reclassifying offenders, including those shifting correctional authorities and those with dual community supervision statuses
- including certain probation populations not previously reported (e.g., persons supervised for DUI or DWI, some persons on probation who had absconded, and some on an inactive status).

The difference between the probation counts for December 31, 2020 and January 1, 2021 resulted in a decrease of 21,390 persons on probation (table 10). The difference between the parole population counts for December 31, 2020 and January 1, 2021 resulted in an increase of 2,120 persons on parole. See *Probation: Explanatory notes for 2021* and *Parole: Explanatory notes for 2021* for states contributing to the largest differences.

Adjustment and changes in parole and population counts

In theory, the change in probation and parole populations from the beginning to the end of the year should equal the difference between entries and exits during the year. In practice, those numbers may not be equal. Some probation and parole information systems track the number of cases that enter and exit community supervision, not the number of persons, while the January 1 and yearend populations represent persons. Some persons are being supervised for more than one charge or case simultaneously. Additionally, all data on entries and exits may not have been logged into the respondents' information systems, or the information systems may not have fully processed all data before submission to BJS.

As a result, the January 1, 2020 probation population plus entries, minus exits, is 64,570 fewer persons than the published December 31 population at the national level. For persons on parole, the calculated total is 7,810 fewer

persons than the published December 31 population. Respondents report all entries and exits from January 1 to December 31 each year.

As discussed, jurisdiction counts reported for January 1 may differ from December 31 counts reported in the previous year. As a result, the direction of change based on yearend data could be in the opposite direction of the within-year change.

In all figures and tables in this report, change was calculated as the difference from January 1 to December 31 within the reporting year. This differs from previous years' reports. This change was due to the large discrepancy from December 31, 2019 to January 1, 2020, as well as an additional discrepancy from December 31, 2015 to January 1, 2016. In both years, the discrepancies were caused by reporting changes in multiple states. Annual change in reports prior to 2013 was also calculated as the difference between the January 1 and December 31 populations within the reporting year. See *Probation: Explanatory notes for 2021* and *Parole: Explanatory notes for 2021* for states with changes to reporting during 2021.

Imputing for nonreporting agencies during 2021

BJS used the following methods to impute missing probation and parole data for key items, including the January 1 population, entries, and exits and the December 31 population. The variation in the number and size of reporting agencies per state requires different imputation methods. Depending on the availability of reported data and the number of reporting agencies in each state, one of the following methods was applied. For detailed calculations, see *Imputation variables and formulas*.

Imputing the January 1, 2021 probation population

When the January 1, 2021 probation population was missing, the December 31 probation population from the last reported year going back to 2017 was carried forward. This method was used to estimate the January 1, 2021 probation population in 88 nonreporting counties and district agencies in Colorado, Florida, Kentucky, Michigan, Missouri, New Mexico, Ohio, and Washington. The January 1, 2021 population was imputed for 2.1% of the total probation population.

Imputing the December 31, 2021 probation population

When counts were missing for the December 31, 2021 probation population, total entries, or total exits, the missing values were imputed by assuming no intrayear growth and setting the missing value to the January 1, 2021 population size. This method was used to estimate the December 31, 2021 probation population in 102 nonreporting counties and district agencies in Colorado, Florida, Idaho, Kentucky, Michigan, Missouri, New Mexico, Nevada, Ohio, Tennessee, and Washington. The December 31, 2021 population was imputed for 2.6% of the total probation population.

Imputing probation entries

Based on the availability of data, BJS used four methods of ratio estimation to impute probation entries for agencies not reporting these data. Total entries to probation in 2021 were imputed for 12.7% of the entry population.

The first method was used for agencies that reported all four key items in at least one year since 2017 and for which the January 1 and December 31, 2021 populations were equal (likely due to the imputation of one or both of those variables). The entries and exits in the most recent of those years were divided by the beginning and yearend populations from the same year (stock overflow), and the resulting ratio was multiplied by the January 1, 2021 population. When this method was used, entries and exits were imputed with the same value. This method was used to estimate probation entries in 76 nonreporting counties and district agencies in Colorado, Florida, Michigan, Missouri, Ohio, Tennessee, and Washington.

The second method was used to estimate 2021 probation entries for agencies that did not report all four core variables in any single year since 2017 or had different beginning and yearend populations. The ratio of 2020 entries to the January 1, 2020 population was multiplied by the January 1, 2021 population to derive the 2021 entries. This method was used to estimate probation entries and exits for 15 nonreporting counties and district agencies in Florida, Idaho, Michigan, and Ohio.

The third method estimated 2021 entries in agencies with small populations. This method summed 2021 entries and January 1, 2021 populations for similar-size agencies within the same state. The ratio of summed entries to summed populations was multiplied by the January 1, 2021 population to approximate 2021 entries for the agency with a missing value for entries. To ensure the stability of the ratio estimator, this method was employed only in states with at least 30 reporting units and was used for 19 agencies in Florida, Michigan, and Ohio.

The fourth method used to estimate probation entries took the ratio of 2020 imputed entries to the January 1, 2020 probation population and applied that ratio to the agency's January 1, 2021 population. This method was used to estimate probation entries and exits for nine nonreporting agencies in Idaho, Kentucky, New Mexico, Rhode Island, Vermont, Washington, and Wisconsin.

Imputing the January 1, 2021 parole population

When the January 1, 2021 parole population was missing, the December 31 probation population from the prior year was carried forward. This method was used to estimate the January 1, 2021 parole population for Maine. This represented 0.1% of the total parole population.

Imputing the December 31, 2021 parole population

When counts were missing for the December 31, 2021 parole population, total entries, or total exits, the missing values were imputed by adding to (or subtracting from) the January 1, 2021 parole population to estimate population change based on what was observed in 2020. The intrayear change in population from January 1 to December 31, 2020—expressed as a proportion of the January 1, 2020 total—was multiplied by the January 1, 2021 total to estimate the 2021 population change. This method was used to estimate the December 31, 2021 parole population for Maine. This represented 0.1% of the total parole population.

Imputing parole entries

To estimate parole entries for agencies that were unable to report these data in 2021 but were able to report in 2020, BJS calculated the ratio of entries in 2020 to the agency's parole population on January 1, 2020 and applied that ratio to the agency's January 1, 2021 population. This method was used to estimate parole entries in California, Maine, and Vermont. Total entries in 2021 were imputed for 7.5% of the entering parole population.

Imputing probation and parole exits

A single method was used to estimate exits from probation that were not imputed with the first method noted above and for all parole agencies. For both probation and parole, BJS added each agency's estimated entries in 2021 to that agency's population on January 1, 2021 and subtracted that estimate from the population on December 31, 2021. For probation, this method was used for 196 nonreporting agencies in Alabama, Arkansas, Colorado, Florida, Idaho, Kansas, Kentucky, Louisiana, Michigan, Mississippi, Montana, New Mexico, Nevada, Ohio, Oklahoma, Rhode Island, Tennessee, Utah, Virginia, Vermont, Washington, Wisconsin, and Wyoming. For parole, this method was used in California, Maine, and Vermont. Total exits in 2021 were imputed for 4.9% of the exiting probation population and 9.2% of the exiting nonfederal parole population.

Probation: Explanatory notes for 2021

Probation agencies vary in their ability to provide counts each year consistent with Bureau of Justice Statistics (BJS) definitions. Some agencies report the number of cases, while others report the number of persons they supervise. Because a person can have multiple probation sentences, counting cases can artificially inflate probation totals. BJS requests that agencies report the number of persons under supervision, and each year some agencies make the conversion, resulting in what appears to be a large decrease from previous years' data. BJS documents these and other reporting anomalies below.

Alaska—Alaska supervises probation and parole in a combined program. The state agency was unable to report probation and parole data separately, so both populations were reported in the probation survey. The January 1, 2021 and December 31, 2021 probation population counts were derived based on the difference between the reported probation and imputed parole count (imputed using the December 31, 2020 parole population count).*

Colorado—Nonreporting agencies in 2021—two local agencies did not report data. The December 31, 2020 population counts were used to estimate January 1, 2021 and December 31, 2021 populations.

Florida—Nonreporting agencies in 2021—seven local agencies did not report data. The December 31, 2020 population count was used to estimate January 1, 2021 and December 31, 2021 counts for these agencies. Four other agencies did not report the number of entries and exits.*

Georgia—Reporting changes in 2021—Georgia has two reporters from the same agency, the Georgia Department of Community Supervision (DCS). One reporter provides counts based on individual-level information from Georgia state employees (probation officers) and represents 45% of Georgia's total probation population. The other reporter provides counts based on summary counts submitted by independent local probation agencies to the DCS and represents 55% of Georgia's total probation population. One agency reported populations by the number of cases but was able to estimate the number of individuals for 2021. For this report, estimates for individuals were used for the January 1 and December 31, 2021 populations. **Idaho**—Nonreporting agencies in and reporting changes in 2021—nine local agencies did not report data. The December 31, 2020 population counts were used to estimate January 1, 2021 and December 31, 2021 populations.

Kansas—Reporting changes from 2020 to 2021—for the state reporting agency, 2021 was a transitional time in which it operated with few staff until later in the year. The probation numbers in the system represented estimates because there were old (inactive) cases and duplicated information had yet to be closed out or updated.

Kentucky—Nonreporting agencies in 2021—one local agency did not report data. The December 31, 2020 population counts were used to estimate January 1, 2021 and December 31, 2021 populations.*

Michigan—Nonreporting agencies in 2021—Michigan has 129 agencies: 1 state agency, representing 46% of Michigan's total probation population; 105 reporting local agencies; and 23 nonreporting local agencies. For the 23 nonreporting agencies, December 31, 2020 population counts were used to estimate January 1, 2021 and December 31, 2021 populations, where available. Other agencies did not report the number of entries to or exits from probation.*

Missouri—Nonreporting agency in 2021—Missouri has 2 agencies: 1 state agency, representing more than 99% of Missouri's total probation population, and 1 nonreporting local agency. For the nonreporting agency, December 31, 2020 population counts were used to estimate January 1, 2021 and December 31, 2021 populations.*

Nevada—Nonreporting agencies in 2021—the state agency did not report data on entries to or exits from probation.*

New Jersey—Reporting changes in 2021—the state agency started reporting on the number of cases in 2021, not individuals as was previously reported. For this report, January 1 and December 31, 2021 population counts used estimates of number of individuals as provided by the agency.

Ohio—Nonreporting agencies in 2021—Ohio has 182 agencies: 1 state agency, representing 3% of the state's total probation population, 151 reporting local agencies, and 30 nonreporting local agencies. For the 30 nonreporting agencies, December 31, 2020 population counts were used to estimate January 1, 2021 and December 31, 2021 populations. Many agencies reported switching their case management systems in 2021, resulting in changes to reporting. The updated system provides better estimates on the number of individuals on probation.*

Washington—Nonreporting agencies in 2021— Washington has 32 agencies: 1 state agency, representing 21% of the state's total probation population, 25 reporting local agencies, and 6 nonreporting local agencies. For the 6 nonreporting agencies, December 31, 2020 population counts were used to estimate January 1, 2021 and December 31, 2021 populations.

Parole: Explanatory notes for 2021

Each year, changes in legislation or offender management systems require states to alter previously submitted data or the data they can currently submit. The Bureau of Justice Statistics documents these changes as reported by the respondents.

Alaska—Alaska supervises probation and parole in a combined program. The state agency was unable to report probation and parole data separately, so both populations were reported in the probation survey. The January 1, 2021 and December 31, 2021 parole population counts were imputed based on the December 31, 2020 parole population count.*

California—Nonreporting agency in 2021—all totals were pulled from publicly available reports on the California Department of Corrections and Rehabilitation website (https://www.cdcr.ca.gov/research/populationreports-2/); however, updated population counts for post-release community supervision and mandatory supervision were not available, and populations were estimated based on 2020 data. Nebraska—Reporting changes in 2021—changes in data reporting for this year include more details on physical locations of persons related to placement in jails or prisons both within and outside of Nebraska. The population change was due to a declining number of persons eligible for parole. During the last several years, the state has implemented mandatory post-release supervision (under the jurisdiction of the Office of Probation Administration within Nebraska) for felony 3- and felony 4-level offenses, which has been tied to the elimination of parole eligibility for persons convicted of these offenses.

Wisconsin—Reporting changes in 2021—detailed data for entries to and exits from parole were new for 2021 and may fluctuate more widely than normal in the next year as reporting procedures change.
